How to Send Certified Mail

Visit a local post office and obtain a Certified Mail Form 3800 and a Certified Mail Reciept

- This form contains a green and white sticker that includes a barcode, which will allow you to track your mail through the USPS.
- The form also contains a perforated receipt, which serves as proof that you mailed the item.
- Write all of the required information on the form, including the recipient's name and address.

Keep records. Collect and keep your receipt that has been stamped with the mailing date. A number that is unique to your mailing allows you to confirm the mail delivery online.

- Keep all documentation for the mailing in a safe place.
- Locate a Post Office or Postal Annex with a Notary

Before going to the Notary

• Have a Manila Envelope Pre-Addressed and paper clipped to the File

Have Green Card and Reciept Filled out Front and Back and paper clipped to the File When you have Documents Notarized, have the Notary make a Stamped Copy of the File as your Record. Keep all Originals! Always mail The Copy be

Seal your Documents in the Manila Envelope and have the Notary Mail the package.
